He added that Windstorm inspectors will be handled by Texas Windstorm Inspectors Association (TWIA) and Texas Department of Insurance (TDI).

It was MOVED/SECONDED (Womack/Norwood) to recommend to the Board at its Regular Quarterly Board meeting on May 25, 2017, to adopt the repeal of § 137.19, Engineers to be qualified Windstorm Inspectors and adopt the removal of all reference to Windstorm in the Sanction Table under §139.35 (b) Sanctions and Penalties. A vote was taken and the MOTION PASSED.
